Dear Resident / Occupier

North West Battersea area, SW11, Controlled Parking Zone (CPZ) – Implementation and permit applications

I wrote to you on 4 July 2022 to notify you of the results of the consultation and the Council's decision to introduce a new Controlled Parking Zone (CPZ) on all Highway roads within the North West Battersea consultation area.

This letter is to update you on progress with the design and implementation of the new CPZ which will be known as the Battersea B9 sub-zone and will operate 10am to 11am, Monday to Friday for the Permit Holder Only bays, and 8am to 6pm, Monday to Friday for the visitor (Pay by phone only) bays.

The new Battersea B9 sub-zone will come into operation on **Monday 20 February 2023**.

- Parking bays will be marked where it is appropriate to park and yellow lines where it is not. Waiting restrictions marked with a single yellow line will operate 10am to 11am, Monday to Friday, unless signed as operating for longer hours. At most junctions and other locations where parking would cause an obstruction, waiting restrictions will apply 'At any time' and will be marked with a double yellow line.
- Installation of posts, signs and lining is likely to commence from the beginning of January 2023.
- Between 10am and 11am, Monday to Friday, only vehicles displaying a valid B9 CPZ permit (resident, business or visitor) or paperless equivalent, will be entitled to park in marked 'B9 Permit Holder Only' bays to be marked on the highway roads with effect from Monday 20 February 2023.
- Permits will not be valid in the visitor (Pay by Phone Only) parking bays (operating 8am to 6pm) unless payment is made using the Council's Pay by Phone service (RingGo)

- Disabled Blue Badge holders will be able to park free of charge and without time limit provided they display a valid blue badge.
- Warning Notices will be issued, instead of Penalty Charge Notices, to any vehicles not displaying a valid permit (or paperless equivalent) during the first week of operation of the new controls.
- The design of the parking layout, a boundary map and a copy of this letter will be available to view on the Council's parking reviews page (see link below).

How to apply for a CPZ parking permit

You will recall from my consultation letter (19 November 2021) that since 2003, all new developments with 10 or more (and sometimes fewer) residential units, and those approved based on being 'permit' or 'car' free, would be unable to obtain parking permits. From **28 December 2022** you will be able to apply for parking permits. Applications for resident or business parking permits and paperless visitor permits from eligible addresses should be made online. Please visit the website on or after 28 December 2022 to register and apply:

You will need to scan and upload your proof of residence/business address and vehicle ownership before your permit can be issued. Please enter **Monday 27 February 2023** as the permit start date, so that you are not charged for the first week of operation. Failure to enter the correct start date could result in your permit being issued with an earlier start date.

Please note that each eligible household may purchase a maximum of 100 resident visitor parking permits per year. Residents aged 70 and over and disabled residents may apply for 200 visitors' permits per year. These should be applied for via the same online permit account.

In-person visits to the Council's Customer Centre are on an appointment only basis. The reception is open Monday to Friday, 9am to 5pm excluding Bank Holidays. Customers can book appointments by contacting the Parking Helpline on (020) 8871 8871 Monday to Friday, 9am to 5pm. Alternatively, customers can use Web Chat on the relevant pages of the Wandsworth Council website.

Each resident who purchases a valid CPZ resident permit is also entitled to 10 free One-hour Zone resident visitor permits a year, for use in zones across the borough that operate for one-hour each day and in which pay & display parking is not normally available during the controlled hour. This concession is provided for residents who occasionally travel outside their sub-zone, to another part of the Borough and need to park during the operational hour of a One-hour Zone.

These 10 free One-hour Zone resident visitor permits are available to resident permit holders on request by completing the online form on the Council's website here: www.wandsworth.gov.uk/parking/parking-permits/resident-visitor-parking-permits/free-one-hour-resident-parking-permits/apply-for-free-one-hour-permits
Permits for eligible requests will normally be issued and posted out via second class post within 10 working days. These permits are not available from local libraries.
