

We are writing to inform you that a contract to undertake reconstruction of vehicle accesses for properties in Kersfiled Estate has been awarded to Pavenet (highway contractors). The work is planned to commence on the 12<sup>th</sup> May 2025, and subject to weather and unknown obstructions in the ground, the duration is estimated to be 4 weeks.

The work includes the replacement of kerbs and reconstruction of vehicle accesses with pedestrian crossings leading to Rosbury, Sprewell and Essington apartments at locations A, B and C shown below.



The works shall be undertaken in stages with parking bay suspension, vehicle access and footway closures in place to ensure safety of all road users, residents, businesses, schools and others whilst excavators and machinery will be in operation along with lorries transporting materials and goods for the works. Any access during the course of the work will be supervised by Pavenet personnel to maintain safety.



The parking suspension and footway closures will be in place for the whole duration of work, however, where possible some parking bays and access may be provided if safe to do so, to minimise any disruption.

There will inevitably be some occasions when the workforce or transport vehicles are within the live lane for short periods of time and in this instance, traffic will be managed using stop and go boards with deliveries planned outside peak hours, wherever possible.

The general traffic management layout is shown below and there will be changes as works progress to provide some parking or better access, which will be assessed by our work teams on site and adjusted accordingly.
